

## **CMP Monthly Report November 18, 2017**

### **Overview:**

This report will contain the activities from mid-October to mid-November.

### **Latest workings:**

Talked with another person from the LA Superior Court (LASC) about how CMP is handling the pre-approved CIMCE courses (i.e., workshops) for them to earn CEUs from RID for their ASL employee interpreters. No one has sent in any PINRAs yet. This is setup on a one-year bases. Expecting them to be submitted in December.

Working with LinguistPD in approving archived webinars for CEUs. They had paid for the CEU processing leaving the participant to only pay for the webinar. CMP has created a PINRA in which LinguistPD provides to the participant, in turn, sends into CMP to be processed. This is an experiment and is scheduled to last only one year. Four archived webinars have been approved. Encouraged LinguistPD to promote on the SCRID Facebook group page.

It is getting that time of the year again when members' cycles are coming to a close. Few members have contacted me asking for assistance with a looming ending cycle of December 2017. They wanted to do an IS. It would be impossible with the short amount of time and the criteria requirement on an IS, to complete it in time. Directed the member to other organizations that have webinars and pre-approved IS to work.

Closed out all but one activity (Nov 18<sup>th</sup> workshop), this does not include the IS ones.

Talked with a member at the Jubilee. She seemed to be interested in taking the CMP position. We talked on 11/10, and I encouraged her to speak with Peggy H. Another member has shown interest in taking over the CMP position and have forwarded her to Peggy H.

Sent emails to those who paid for activities but cancelled them. The policy is to not refund but to hold the monies for a future activity. The email is to be sent to the future CMP Sponsor from the person wanting the monies to be applied to an activity and the reason for not making a payment.
