President's Report

- **Meetings and conferences:**
 - Coordinator's Access Network (CAN) Meeting is due to be set up for October 21st at LiNKs Interpreting Service (Goodwill) in Long Beach. Tiffany Green has volunteered to attend. I am still hoping to attend, but not sure if I will be available.

- **Board development:**
 - Looking for a replacement for the Secretary. I am reviewing the Secretary position description (sent to Leadership for input), and will send to eligible SCRID members (dual RID & SCRID membership for at least one year) via email and on FB this week.
 - Supporting Kathleen in looking for a replacement for her as CMP Committee Chair. We are encouraging co-chairs, as we do for most SCRID committees.
 - Working with the Public Relations chair, Beth D'Addario, on appointing a co-chair. I hope to meet with them both to review the committee scope of work and procedures next week. Still finalizing the position description, promotion protocol and schedule and brochure re-design. (I have redesigned the Deaf-centered brochure, with Jerrin George's help.)
 - Website: Working with Website Committee chair, Jerrin George, on the migration of the Word Press site to the Wild Apricot Site (WA). Don't forget to use the sign-in instructions and post your reports on WA from now on. Let us know if you need support.
 - Continued communication with the PDC co-chairs, Kim and Cyndy, and support for the Face-to-face board meeting and workshop in November.
 - PPM updates: Compiled a revision of committee chair positions descriptions and sent to leadership for review. I will be reviewing the officer descriptions with each officer as well and look at providing procedure instructions for each one.

- **ProTactile Workshop**
 - January 27 & 28, 2018 with Hayley Broadway and a second presenter (TBA) (Contract should be signed by the time this meeting is convened)
 - Exhibitor/Sponsor levels:

- After the above are confirmed, CEU docs will be filed
- A save the date flyer has been created by Jerrin (thank you!) and is about to be approved by Hayley (this was not done at our last meeting as we were waiting for approval of the flyer. Asking promotion team to send it through the pipeline very soon.
- I am setting the registration prices, based on budget data to:
 - DeafBlind individuals: \$20/pp (max 18) (with an option to request waiver)
 - Hearing or Deaf Interpreters: \$55/pp (max 25)
 - Special Service Providers: \$30/pp (max 15)
